**EXTENSION OF ADHOC APPOINTMENT OF SECTION OFFICERS**

- (a) These appointment are made purely as a stop gap arrangement and can be terminated without any notice for administrative reasons or on availability of regular incumbents;
- (b) The adhoc appointment will not bestow on these officers a claim for appointment to the above post on regular basis; and,
- (c) The service rendered as Section Officer on adhoc basis would not count for seniority in that grade and for eligibility for promotion to the next higher grade.

2. Approval of the DOP&T has been obtained for extension of adhoc appointment of these officers till 31.12.2011 vide their Diary No. 87368/CR/2011 dated 07.12.2011.
